1. SCOPE

This procedure provides guidance on the control of Ships Nautical and Technical Publication list.

2. CODE

3. RESPONSIBILITY AND AUTHORITY

Master shall ensure that the ship's Nautical and Technical Publication Library is maintained updated. The list includes Publications which are mandatory per Regulations and others which are required by the Company.

4. NAUTICAL AND TECHNICAL PUBLICATION LIST

Fleet vessels are enrolled in **REGS4SHIPS** (OneOcean) program which contain the mandatory Maritime Regulations. The Digital Publications are on a searchable database within the program.

Provided to each vessel by REGS4SHIPS. The Regulations are kept fully updated and amended by online corrections:

- Contents of REGSHIPS are as follows:
- Flag State documentation.
- IMO Codes, Conventions, Circulars, Resolutions.

- EU Legislation.
- MCA and M notices.
- Miscellaneous publications (Example Code of safe working practice).
