Anchorage approach	Vessel must call Gibraltar VTS at least 2hrs prior to arrival and request permission to drop anchor.Western Anchorage: Vessels anchoring for operational reasons generally use Western anchorage. Sheltered from the north, east and west with depths up to and over 100 m., bottom mostly comprises sand and
Min. depth at anchorage/Channel	Minimum depth at Western anchorage is 50m
Pilot performance/Tugs condition	Pilotage is compulsory for berthing, unberthing, shifting anchorage or when manoeuvring in the bay within port limits. Vessels at anchor may leave without Pilot assistance. Vessels should give 2 hours' notice before arrival on VHF Channel 12. Vessels should call again when 5 n.m. from the pilot boarding area. Pilots normally board vessels at a point 1.25 n.m. SW of Europa Point. Vessels leaving a berth should give 1 hours' notice before departure. Tugs not applicable for anchorage.

Berth Restrictions	There are several areas within port limits where anchoring is prohibited including within a 0.3 n.m. radius of the SPM, in the area of submarine pipelines and within the inshore area of Estrecho Nature Park in the SW of the bay. The Gibraltar Port authority has declared a restricted area of radius 1nm centered on Europa pt.Lt.Entry into or transit through the Restricted
