Port Details	
Anchorage approach	Rotterdam has reportedly extended the anchorage area into a position 15km NW of Scheveningen, due the number of waiting and storage vessels off the port. Prohibited anchorage areas: The Maas Entrance in an area extending from the port entrance Nooderhoofd 3.5nm seawards and extending 600m to the north and south of the leading lights 112°. Also prohibited on the rivers and where so indicated by warning signs. It is strongly recommended not to anchor in some following areas.
Min. depth at anchorage/Channel	Basins on the right bank of river Maas, Maashaven and Rijnhaven: Vessels with a length of 180m and more with sufficient UKC are generally tidebound.
Pilot performance/Tugs condition	2 Pilots and 2 tugs used.

Minimum depth at Berth/approach/UKC concern	13.70m / 2.0 mtr UKC (during HW time)
Mooring arrangement	4+2 Fore and Aft
Berth Restrictions	Restrictions for entering Europoort: Tankers with a draught exceeding 21.9m (SW); some berths have tide restrictions. While entering Europoort, tugs are made fast just inside the breakwaters. At all times tug's hawsers must be used. The time at which deeply loaded vessels destined for Europoort enter the New Waterway depends on the prevailing circumstances and is always subject to agreements made between the Pilot Service and the Harbour Coordination Centre. Botlek: Max draught 13.4m SW, exceptionally 13.7m SW, under certain conditions. All harbours in Rotterdam can be entered at any time day and night.
