Anchorage approach	Port area, depth 17.0–19.0 m., sandy/muddy bottom. Safe anchorages in case of SE wind near Rt Vilizan and in case of NE wind near Debeli Rt (Punta Grossa).
Min. depth at anchorage/Channel	
Pilot performance/Tugs condition	Pilotage is compulsory for all vessels over 500 gt. Pilot boards in position 45°33.96N 13°41.45E (in the vicinity of the Fairway Lt buoy). Five tugs available (1,472 kW, 1,560 kW, 3,040 kW, 4,760 kW and 5,280 kW). Minimum number of tugs required for berthing and unberthing depends on regulations. Firefighting tugs available.
Other information	Work is underway with dredging operations to deepen Basin I. This will increase the maximum draught of vessels using the Container Terminal to 13.0m

Minimum depth at Berth/approach/UKC concern	Three dedicated berths (TRT), total length 637 m. Max. arrival draft 17.2 m. Drafts over 16.5 m. subject to Harbour Master's written permission. Handles ores, coal and coke. Maximum granulate size 200 mm.
Mooring arrangement	As per Port regulation
Berth Restrictions	All vessels enter port throughout 24 hours, except for oil and chemical tankers when visibility is less than 400 m. and wind greater than Force 4.

Other information (fendering etc)	A multipurpose port well positioned and sheltered harbour which ensures safe berthing. Specialised terminals handling all type of vessels carrying bulk, liquid, general and container cargoes
