Anchorage approach	Suggested anchorage is 3-5nm SE of the South Breakwater, sandy bottom. Caution should be exercised in high SW and NE winds. The anchorage area immediately to the N of the entrance channel is prohibited due to the location of an offshore pipeline.
Min. depth at anchorage/Channel	An inner breakwater, exhibiting a light, extends approx 70m S and SSE from the N entrance point. Within the harbour entrance, which is marked by lightbuoys and dredged to 19.5m LWOST over a width of 300m, the harbour opens into a basin dredged to 19.0m and containing a turning area with a diameter of 800m. Berth depths are dredged to 19.0m LWOST.
