Good Day!

Please find below a Quick Guide for Master to enter Users and set up TrACE on board your good vessels

Kindly proceed with the following steps to get started :

1.Double Click on '**TrACE Launch'** icon from desktop and then click Enter button. 2.When you click on '**ENTER** " button, a Log-In screen of two windows will be displayed '**I am the Admin'** and '**I am a User'**. Click on 'I am Admin' (as shown below).



 The log in window "Welcome Admin" is displayed > enter the Log In details and click on ENTER.

Log in with the USER ID and PASSWORD provided for your vessel.

2.Once you click on enter you will be redirected to below page.



From here you can go to User data Management tab to add New crew members in TrACE. (Attached please find TrACE User Data Management guide for detail understanding of how to add crew in TrACE).

Also please find attached steps guide to Sign off crew in TrACE software.

Once Crew members are added in TrACE, tokens need to be assigned to crew. Kindly follow below steps to assign tokens:

Next Step is Assigning Tokens to Crewmembers :

Tokens are_used for carrying out assessment after viewing videos. Users can view KARCO Videos unlimited times without any token. Once video is viewed and to carryout assessment for the same 1 token will be deducted from the user. So, tokens should be assigned to the users as per training needs to be carried out.

- 1. Click TOKEN MANAGEMENT tab on the home page > Click on ASSIGN TOKENS
- 2. In the Assign Tokens you will see the list of all the crew members (users) on board. In the last column) > Enter the number of tokens in the box and click Assign. This is to be done for each crew member on the list.
- 3. The assigned tokens are from your ship's account to your crew for assessments once they have consumed you may assign additional Tokens.

Once above steps are carried out crew members can login from "**I am User login section**" using their UID assigned by master in TrACE User data management section and carry out their training.

KARCO videos with assessments:

This has to be followed by completion of the feedback form, to ensure that this training gets recorded and same is evident from the change of the completion percentage for the individual and also for the vessel.

This has to be followed by completion of the feedback form, to ensure that this training gets recorded and same is evident from the change of the completion percentage for the individual and also for the vessel.

TrACE Admin and User guide are already included in TrACE packages sent to the vessels.
