Dear Sirs

The Technical File (hereafter abbreviated TF) specifies the combustion-related components according to the IMO regulations.

Please refer to "A Guideline to the Unified Technical File" enclosed with Service Letter SL05-446/KEA.

In some cases we have experienced that the TF only includes the engine builder's ID number and not the corresponding MAN B&W Diesel part number.

For your convenience, we offer to check your technical file and, if necessary, initiate an update of the TF by an approved amendment from the actual classification society.

Please send a copy of your TF and a copy of the IMO Annex VI certificate from the authorised classification society to our Classification Department, Dept. 2110, by mail or e-mail. To cover additional members in the same engine group, we need a copy of each IMO Annex VI member certificate.

This service is free of charge. However, we will charge you for possible classification costs.
