Owners and operators of MAN B&W two-stroke marine diesel engines.

**Summary**

Introduction of new personal safety equipment.

Dear Sirs

In recent years, focus has sharpened on quality and personal safety in the global maritime market. MAN Diesel & Turbo has therefore introduced three different safety packages for our licensees to supply together with the delivery of new two-stroke engines; a compulsory type and two different optional types, due to differences in CE and ANSI standard approvals. The plates enclosed provide further details.

This new safety equipment has been implemented in MAN Diesel & Turbo's design documentation for all two-stroke engine orders as of 1 January 2010. As a consequence of this safety improvement, our licensees must deliver the compulsory equipment as standard with all new engines ordered after 1 July 2010.

Despite the fact that the first sets of compulsory fall arrest block and rescue harness will not be delivered from the licensees until the middle of 2011, we recommend that all vessels already in service procure the above-mentioned safety equipment on board as soon as possible.


